1. Comprehensive Curriculum

Hold an active CMMC Certified Professional (CCP) Certification; and Obtain or have a Tier 3 determination from DoD; and Apply & Remain in good standing with the CAICO; and Sign and Comply with agreements as part of the application process Pay Fees (initial application and annual renewal fees) Complete CMMC Certified Assessor class/course offered by an Approved Training Provider (ATP), formerly referred to as a Licensed Training Provider (LTP); and Pass CMMC Certification Assessor examination; and Have at least three (3) years of cybersecurity experience; and One (1) year of assessment or audit experience; and Hold at least one baseline certification aligned to the Intermediate and/or Advanced Proficiency Level for the Career Pathway Certified Assessor 612 from the DoD Manual 8140.3 Cyberspace Workforce Qualification & Management Program. https://public.cyber.mil/dcwf-work-role/security-control-assessor/

2. Training Providers and Delivery Methods

Authorized Training Providers (ATPs): CCA training is delivered by ATPs authorized by the CMMC Accreditation Body (Cyber AB).

Instructor-led Training: Most CCA courses are delivered in an instructor-led format, either in-person or virtually, providing interactive learning and expert guidance.

Self-study Options: Some ATPs may offer self-paced online courses with comprehensive materials, self-study guides and resources.

3. CCA Training Curriculum

Once you meet the certification requirements you can enroll in a Cyber AB-approved CCA training course delivered by Approved Training Provider (ATP) listed in the CyberAB MarketPlace.

The topics include:

CMMC Assessment Process (CAP): Deep dive into the official assessment methodology, including scoping, documentation, and reporting requirements.

Assessment Practices: Hands-on training in applying assessment procedures and evaluating an organization's implementation of CMMC practices.

Instructor Qualifications: CMMC instructors are authorized to teach CMMC CCP and CCA classes by CAICO. They are listed in the CyberAB Marketplace.

Delivery Method: CAICO mandates Virtual Live or Live Instructor led training. Supplemental training and material can be in any form delivered by ATP. Many ATPs provide hybrid training, self study training, elearning and so on.

Reputation and Reviews: Research the provider's reputation and read reviews from past participants. Also look at what each ATP offers in their training - key deliverables for every training. These are the core differentiators that matter in the effectiveness of CMMC training.
